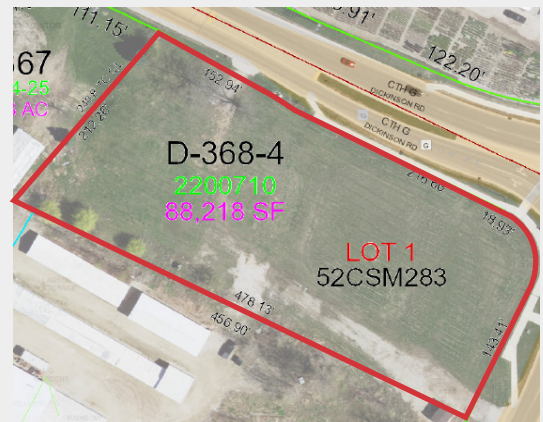

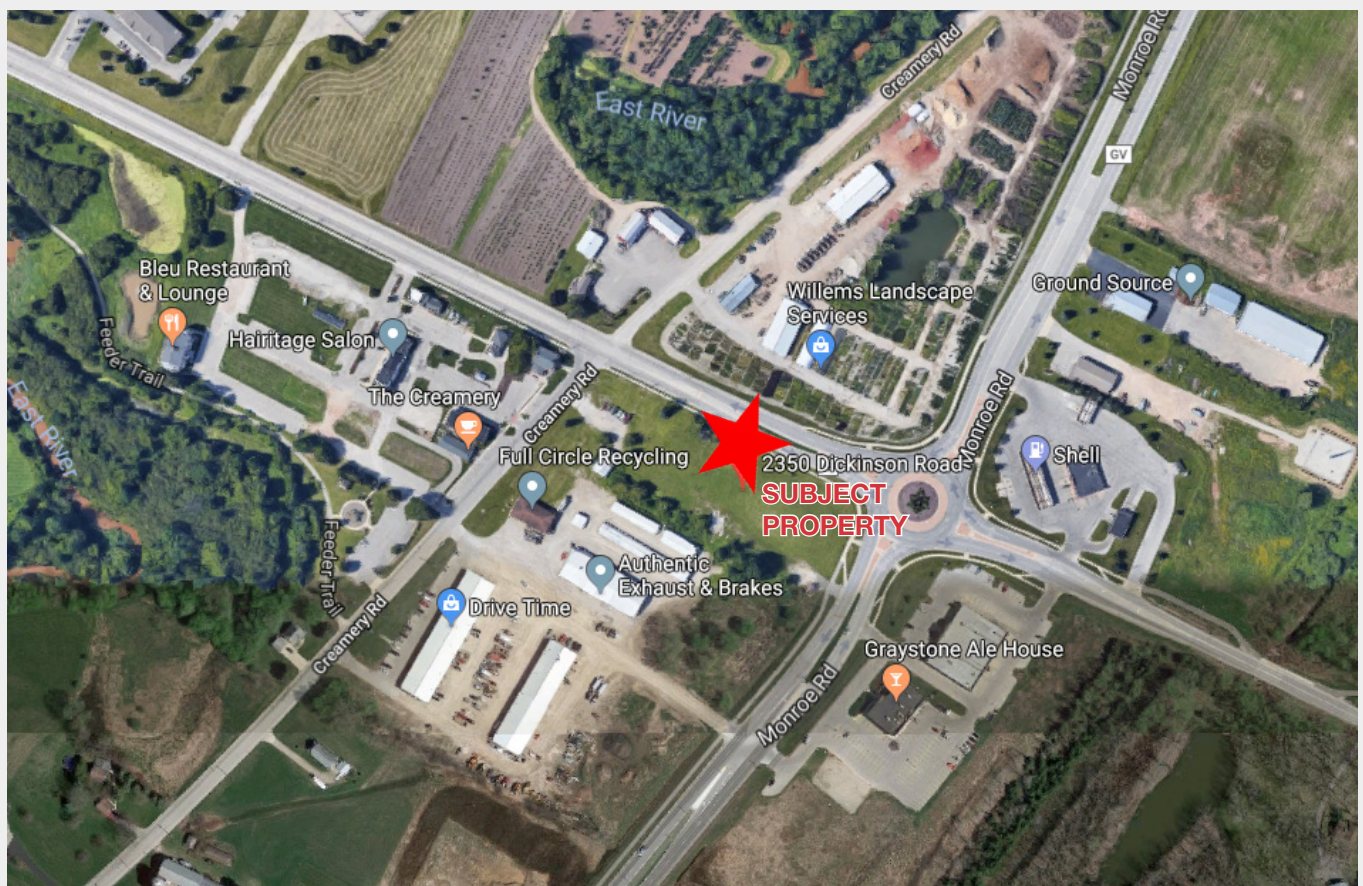

**DISCLOSURE TO NON-RESIDENTIAL CUSTOMERS**

14 (e) The duty to protect your confidentiality. Unless the law requires it, the Firm and its Agents will not disclose your
